22nd Annual CTRC Volunteer Recognition BBQ: CTRC's remarkable group of hardworking volunteers and their families will gather for the 22nd annual volunteer recognition BBQ at 3:00 PM on Thursday, August 18, at History San Jose on Phelan Avenue just East of Center Road in San Jose. The BBQ is again being provided by the Santa Clara County Firefighters Local Union 1165, the Singing Conductors will perform, a historic trolley will be running, beverages are again provided by Bottomley Distribution and the event is being sponsored by HNTB Engineering and Hatch Mott McDonald Engineers once again. Because of our wonderful sponsors, the BBQ is free for the volunteers and friends, though a RSVP to help with the planning is required to 408-924-7561 or 'mccarthy@mti.sjsu.edu'. Vice Mayor Cindy Chavez and other dignitaries will join the CTRC Board in honoring the volunteers who have donated almost 300,000 hours to the trolley project and locomotive 2479 since CTRC's founding in 1982.

A special event for this BBO will be the presentation of the formal dedication plaque for the trolley barn and the recently completed trolley inspection pit honoring the designers and contractors who donated their services to build those facilities. The plaque will also remind us of the time capsule that was imbedded under the trolley barn that is to be opinioned in 2034, which is 50 years after the building's construction.

Seems like that happened just yesterday but, during that time, CTRC has rebuilt and maintained nine historic trolleys, built the barn, constructed over 1/2 mile of electrified trolley track with another 1/2 mile built and ready to be electrified, and is nearing completion of the reconstruction of Locomotive 2479-and much more. It's estimated that, in the past 22 years CTRC has provided over \$20 million in donated capital investments and free services to our Valley's residents. Congratulation to all, especially the CTRC volunteers!

The annual CTRC Board of Directors meeting will convene at 3:00 PM just before the BBQ in the Board Room of the historic Pacific Hotel at History San Jose. That meeting is open to the public and all are welcome.

Trolley Barn Inspection Pit: The Pit is done!! Thanks to Marv Bamberg's donated

CTRC BOARD MEETING MINUTES

Attendance: Marv Bamburg, David Crosson, Rod Diridon, Mac Gaddis, Mike Kotowski, Art Llovd, Ken Middlebrook, Larry Murchison, Bob Schneider, David Svlva, Brendan McCarthy

Minutes: M/S/P to approve the minutes of 02/17/05.

Chair's Report: President Diridon reported the progress of setting up the museum with the City of San Jose. Diridon has spoken with Council members Chavez and Yeager and they are interested in the idea. Diridon also spoke with SJ Redevelopment Agency Director Harry Mavrogenes, who had been previously unaware of the proposed museum project. He is enthusiastic about the idea, but will need to follow the Council's lead on the issue. All indications are that going public with the proposed museum would be disadvantageous and CTRC will have to put it on hold until guidance is received form Council members Chavez and Yeager. The land is a possible site for a baseball stadium and which the Mayor is working hard to build. CTRC will have to wait until that issue has been resolved. Santa Clara is still a fall back option. There are two sites available in SC but are not optimal.

Financial Report: Diridon (reporting for Treasurer Annette Nellen) reports that the existing cash balance is healthy and will be supplemented pending reimbursements from the county. President Diridon has been in touch with the county several times to attempt to speed up the reimbursement process, but has been, as of yet, unsuccessful. Diridon will continue to be in touch with the county to attempt to get CTRC the reimbursements to which it is entitled.

Dan Moors of Berger Lewis Accountancy is in the process of completing the annual audit and has agreed to donate audits for CTRC each year. All indications are that Berger Lewis will deliver a clean audit soon.

Current Projects:

A. Trolley Barn/History San Jose - The trolley inspection pit concrete was poured 5 weeks. Thirty seven yards of concrete had to be used instead of 22. Mac Gaddis was able to run car 124 into the Barn. He had to remove some rotten ties and is concerned that there may be more which he'll remove as needed. With regards to questions about the inspection pit, Gaddis indicated that stairways would likely be needed on both ends of the pit and that Gene Martin would come up with a design. Gaddis also reported that the Merryweather was shipped for repairs.

Rod was able to obtain the needed certification stamps for the Happy Hollow Line electrification and the project plans should be approved by the City of San Jose soon.

B. Locomotive 2479 – Jack Young – Progress is continuing on this project and the current focus is on getting wheels under the Locomotive and

inspecting the shoes and wedges. Robert Franzen from Steam Service of America was able to be on the site for one day in April and was able to give valuable advice regarding the final work on the driving wheels. Jack also reported that there are a significant number of welding projects (10-15) that need to be done on the Locomotive and that John Blaine has been very helpful with the welding. Unfortunately, a certification is required and with only one welder working on it, delays may occur.

- C. SCC Rail Museum The board again recognized Marv's design work and Larry Murchison's museum model and its effectiveness in getting Cindy Chavez and Ken Yeager excited about the museum.
- D. Happy Hollow Rail Extension Once the plans have been approved to the City of San Jose, Rod and Mac Gaddis will need to have a meeting with Julie Marks, Deputy Director of Parks. Rod has met with her before and she already gave her OK to the project in concept.
- E. Volunteers Report Ken Middlebrook reported that the volunteers were working on re-wheeling the locomotive and he hoped that the completion of that project would go a long way towards boosting the group morale. On the Trolley Barn side, Ken recognized the effort made by the volunteers and the enthusiasm they have brought in recent days and months. Next on the agenda for volunteers may be a push forward electrification. Bob Schneider was especially thanked for his leadership.
- **New Business**
 - A. Acquisitions Ken reported that CTRC's Steam Locomotive 1215 in Portola would need to have the asbestos removed soon and a storage site in the San Jose area found. He reported that he will get a contractor to do asbestos abatement and will report on further progress.
 - B. Historic Heritage Commission/Grant Applications Rod Diridon reports that the Historic Heritage Commission will not be doing a cycle this year. We will apply for a grant next year after the 2006 Parks Charter Measure passed creating more funding, hopefully.
 - C. Fundraising Efforts Nothing new to report

Recognition plaques for the pit will need to be made for the designer, contractor, volunteers, and the County. That plaque should be placed where the public can see it, not down in the pit. Brendan will be working to get the plaque completed so it can be unveiled at the August 18 Barbeque. Rod noted that Coast Engraving and Kearney Pattern Works have agreed to donate the pattern and casting.

Next Meeting – The annual Board meeting will be held on August 18th at History San Jose at 3:00pm immediately preceding the Volunteer Recognition Barbeque. County Fired District Local 1165 will do the BBO, Bottomley Distributing the beverages and HNTB and Match Mott (Continued on page 3)

FRED PARKIN

Born in San Francisco Fred passed away on June 27,2005, in Santa Clara at the age of 86. Loved by all who knew him, he is survived by his devoted son Alan, "daughter" in-law Glenda, grandchildren Jennifer and Alan II (AJ), nephew Lyle Wetherford, and wife of 9 years, Jean.

Fred's life is notable for having worked as a machinist in three jobs: all related to travel. His first career was 23 ¹/₂ years as a machinist for the Southern Pacific Railroad. When duty called in WWII, he joined the Navy and served proudly as a machinist on board the destroyer, USS Stickel, on convoy duty with the Atlantic fleet. After the war, he returned to the railroad, married, and settled in South San Francisco to raise a family. He resigned from the railroad in 1962. During retirement, Fred and his wife of 45 years, Dorothy, traveled to explore many foreign countries, until Dorothy's death in 1995. In 1996, he remarried, bought a motor home and he and his wife, Jean, continued to travel by train, plane, boat, and motor home.

Most Saturday's Fred could be found working at the Santa Clara County Fairgrounds on the California Trolley and Railroad Corporation museum project. Near and dear to his heart was the restoration of the 4-6-2 steam locomotive Southern Pacific #2479. He had worked on this locomotive when it was part of the Southern Pacific line and gladly volunteered 1000's of hours toward its restoration for future generations to enjoy.

Utilizing his professional experience, Fred custom machined over 200 threaded studs for locomotive #2479 on the small lathe.



John Ezovski summed our mutual feelings toward Fred: "He was a wonderful teacher. I spent many hours with him next to me guiding me in the creation of pins, bushings and other objects on his trusty lathe. It will be very difficult standing next to the Rutland knowing he is no longer amongst us."

His machining has been vital to the progress made to date on the restoration and we will be forever indebted to his contribution. Thank you, Fred.

WATER TOWER INFORMATION



In early July 2005, the large steel water tank located at the Diridon depot in San Jose, California was reinstalled after a two vear cosmetic restoration funded by the Valley Transportation Agency's Vasona Light Rail Project. The tank's new location, adjacent to the Park Avenue under crossing, is approximately 1/4 mile south of its 1935 site. Currently serving nearly 100 passenger trains everyday, the depot and several complementing structures, including the water tank, are listed on the National Register of Historic Places.

Construction of a the 7 mile light rail extension required the removal of the water tank. After receiving several bids toward the tank's restoration which were nearly double the orginal \$250,000 estimate, the transportation agency

held public hearings on the potential disposition of this historic structure. Due to the overwhelming interest from local residents and the preservation community, the agency agreed to move forward with the tank's restoration. The tank was dismantled and subsequently stored in a nearby maintenance yard for the past two vears.

Photo research indicates the water tank may have been originally used at Southern Pacific's Market Street depot in downtown San Jose and, as a result, would predate the 1935 Diridon depot by several decades. While no longer a functional storage tank, the 55,000 gallon and 48 ft high structure will continue to stand as a visible reminder of when steam locomotives such as Southern Pacific's Daylight class served the San Jose community.

Cadillac: The Cadillac was also on display at the Muster Team's museum during the Independence Day weekend. It was driven over. It is now back in the Restoration Shop for further "tuning". Total hours to date from our start of work (June 2002) to July 1st was 8491 hours over 37 months.
